### Detailed Information

#### 1. Application

- Upon confirmation of application status (i.e. the Candidate is eligible for entry to PE), payment of first year Candidate Fee is required.
- Annual Candidate Fee will be billed in January for subsequent years of candidature.
- Active candidates need not to submit Assessment Application Form during the period of valid candidature (5 years).

#### 2. Module (Examination) Enrolment

- Examinations are available twice a year, in the months of May and November.
- Candidates may enrol for a maximum of 3 modules per term by the Module Enrolment closing date.
- Modules need not be attempted in a particular sequence and are not compulsory every term. Candidates can attempt modules at their own pace, provided that examinations for all modules are successfully attempted within the candidature period of 5 years.
- Candidates can only enrol for modules after payment for candidate fee is made.

#### 3. Optional Revision Workshop

- Enrolments received by this date will be entitled to discounted rate.  
Please refer to "Revision Workshop Enrolment Procedures" in website for details.

#### 4. Written Examination

- Module examination dates corresponding to enrolled modules are listed in the table above.
- All examinations will commence at 10am and end at 1pm on each of the given dates, unless otherwise stated.
- Results will be released on the stated dates. Candidates are required to log in to their individual account to view their published results.
